## **Personal Data**

We do not collect any data other than those that are subject to transformation. We use only data, that you provided. During the processing, we are using a third-party service API. We don't share your data with other services. Your uploaded files will not be given or sold to anyone. No one except you will ever have access to converted file, because all files are getting deleted right after each conversion, therefore we can assert, that we don't store any data. We don't look into your files and don't make any backups.

### Security

We do a lot to make our application as secure as possible. All transfers are made by SSL encrypted channel. All files are additionally encrypted during the transaction. All requests to server pass validation. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches. ## Main statements of third party service privacy policy

#### Personal Data Collected by Us

We do not collect any data from your uploaded files.

#### Handling of Your Uploaded and Converted Files

We do not look into it. You can delete your uploaded files at anytime. We do not make any backups.

In the course of providing the service your files are transferred to and from servers. We **do not** read, look into or mine any data from your files or its metadata. We do not make any copies of it. All file processing is done by machine and there is no human interaction with your files. Your files are deleted immediately and irreversible from our servers when you click the "×" symbol (on the right beside the Download button). This will happen automatically at the latest after 24 hours.

#### **Sharing Your Data**

#### We do not share your data or files.

Your personal data and your uploaded files will not be given out our sold to anyone. No one, you did not provide the download link, will ever have access to your converted files. Please note that we may have to provide your data to the law enforcement authorities (for example, the police) at their request.

#### **Keeping your Data**

## Files are deleted after 24h at latest. We keep your personal data until it is needed for the provision of our services.

We will keep your personal data for as long as it is necessary to provide you with our services. If your personal data is no longer necessary, we can keep it in an identifiable form for maximum one year. Your files are deleted immediately and irreversible from our servers when use the delete button. This will happen automatically at the latest after 24 hours.

#### Security

We are committed to protect your personal data and your files. All transfers from and to server are SSL encrypted. All servers are located in the European Union, are protected and cannot be accessed by third parties.
